

Abortion

Abortion means emptying life from pregnant mothers' womb prematurely which may take many forms and may be classified into natural accidental spontaneous and induced categories.

Natural abortion may cause due to mother's bad health condition of the mother of the fetus fear

An accidental abortion may be the result of direct or indirect impact of forces or stress on uterus.

Spontaneous abortion may be caused due to some pathological reason thereby necessitating the emptying of the womb with intent to destroy prior to its birth.

The acts of abortion in general and female foeticide in particular have become very common and spreading very quickly throughout the country. This practice becomes questionable whether the foeticide in general should be punishable? This questions bear both legal and sociological importance.

On the other hand it may be asked whether or not the issue is one of the rights to life because the foetus is the origin and the end of life.

The court refused to bring unborn life within the ambit of everyone and held that the term everyone is limited alone to born human being. Foetus has no right of action on right at all until birth. The succession cases have been mention there is no difference from conception of the child who may have succession rights.

In order to discourage such practice, the Indian penal code strictly prohibits "miscarriage". It declares that whoever (including the woman) causes a woman

with child to miscarry... not caused in good faith for the purpose of saving life of the woman, be punished with the imprisonment of either description for a term which may extend to three years, or with fine, or with both, and, if the woman be quick be with child, shall be punished with imprisonment of either description for a term which may extend to seven years and shall also be liable to fine.

Whether you believe humans have evolved to be the highest form of life on earth or you believe as I do. For women who have had in an abortion, the risk of ectopic pregnancies doubles and the chance of a miscarriage and inflammatory diseases also increase.

Ultimately, a women's right to choose is an extremely sensitive issue and one where there both pro-choice and pro-life Advocates can make compelling argument. One thing is certain both side of pro-life and pro-choice make sense to their proponents and raise concerns to their opponents. In the birds of an anonymous "no women want an abortion either she wants a child or she wishes to avoid pregnancy"

One of the main arguments abortion advocates used was that unwanted children were victims of child abuse, and were more likely to grow up to be criminals. In America the national abortion rights action league, now NARAL pro choice America, stated :

"a policy that makes contraception and abortion freely available will greatly reduce the number of unwanted children, and thereby curb the tragic rise in our country....legal abortion will decrease the no. of unwanted children, battered children, child abuse cases, and possibly subsequent delinquency, drug

addiction, and a host of social ills believed to be associated with neglectful parenthood.
